- 1. Copies of relevant contracts to be submitted along with bid in support of having sup plied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

12. Past Project Experience

For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:

- a) Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.
- b) Execution certificate by client with contract value.
- c) Any other document in support of contract execution like Third Party Inspection release note, etc.

13. Purchase Preference (Centre)

Indian suppliers of this item are not allowed to participate and/ or compete in procurement by some foreign governments. Bidders / products from such countries are not eligible / not allowed to participate in this bid in terms of clause 1 (d) of Public Procurement (Preference to Make in India) Order, 2017.

14. Purchase Preference linked with Local Content (PP-LC) Policy

The bid clause regarding "Preference to Make In India products" stands modified in this bid and shall be governed by the PPLC Policy No. FP-20013/2/2017-FP-PNG dated 17.11.2020 issued by MoP&NG as amen ded up to date. Accordingly, bidders with Local Content less than or equal to 20% will be treated as "Non Local Supplier". The prescribed LC shall be applicable on the date of Bid opening. Sanctions on the bidder s for false / wrong declaration or not fulfilling the Local Content requirement shall be as per the PPLC polic y.

Further following additional provisions are added in the certification and verification of local content provision of the Preference to Make in India clause:

- i. In case of foreign bidder, certificate from the statutory auditor or cost auditor of their own office or subsi diary in India giving the percentage of local content is also acceptable. In case office or subsidiary in Indi a does not exist or Indian office/subsidiary is not required to appoint statutory auditor or cost auditor, cer tificate from practicing cost accountant or practicing chartered accountant giving the percentage of local content is also acceptable.
- ii. Along with Each Invoice: The local content certificate (issued by statutory auditor on behalf of procuring company) shall be submitted along with each invoice raised. However, the % of local content may vary w ith each invoice while maintaining the overall % of local content for the total work/purchase of the pro-rat a local content requirement. In case, it is not satisfied cumulatively in the invoices raised up to that stage, the supplier shall indicate how the local content requirement would be met in the subsequent stages.
- iii. The bidder shall submit an undertaking from the authorized signatory of bidder having the Power of Attor ney along with the bid stating the bidder meets the mandatory minimum LC requirement and such undert aking shall become a part of the contract.

15. Bidder financial standing

The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankr upt. Bidder to upload undertaking to this effect with bid.

16. Warranty

Warranty period of the supplied products shall be **3 years** from the date of final acceptance of goods or af ter completion of installation, commissioning & testing of goods (if included in the scope of supply), at I-HU B QTF. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee peri od. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Mainten ance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

17. Service & Support

BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

18. Installation

Installation, Commissioning, Testing, Configuration, Training (if any - whichever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.

19. Termination of Contract

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i. The Seller fails to comply with any material term of the Contract.
- ii. The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii. The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Peri od and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv. The Seller becomes bankrupt or goes into liquidation.
- v. The Seller makes a general assignment for the benefit of creditors.
- vi. A receiver is appointed for any substantial property owned by the Seller.
- vii. The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

20. Optional Clause

The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bi d quantity at the time of placement of contract. The purchaser also reserves the right to increase the order ed quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted r ates. Bidders are bound to accept the orders accordingly.
