<b>Refer Tendered Specifications: Page 01, Section: Seed Laser</b>		
1	For the seed Laser, the tender specifications have linewidth of 1kHz. Request you to accept the Linewidth <5KHz.	We accept the seed laser linewidth < 5kHz.
<b>Refer Tendered Specifications: Page 01 and 02</b>		
2	Please clarify whether all the three items (Seed Laser, Laser Power Amplifier and Frequency Doubling Module) are required from the same OEM or would different manufacturers be acceptable.	It is not necessary that all three items are from the same OEM. However, if not from the same OEM, it has to be demonstrated that all three modules are compatible with each other and have been tested to work together. We will require a test sheet for the same.
<b>Refer Tendered Specifications: Page 02, Section: Frequency Doubling Module</b>		
3	Please clarify whether SHG crystals are acceptable, or do you need a plug and play module only.	Just crystals are not acceptable. It needs to be a plug and play module. A test report that shows seamless working of all the modules together will be required.
<b>Refer Tender Document Page 02</b>		
4	Please clarify whether MSMEs are exempted from the Earnest Money Deposit (EMD).	Registered MSMEs are exempted from the EMD. However, the exemption is only for the OEM/OSP and NOT for Traders/Resellers.
<b>Refer Tender Document Page 02</b>		
5	Please clarify in what forms the EMD can be submitted.	EMDs can be submitted through: <ul style="list-style-type: none"> <li>i. Demand Draft</li> <li>ii. NEFT/RTGS</li> <li>iii. Bank Guarantee (through any Indian Nationalised Bank only)</li> </ul>
